Business Meeting Minutes

Nov 16th, 2014

Miracle Area:

Hello, Family;

The Miracle Area of Narcotics Anonymous is doing well, and recovery seems to be thriving. We still have all of our service committee chair positions filled, with a few co-chairs taking training for upcoming leadership duties.

On a sad note, the Last Chance group of Narcotics Anonymous has indicated they can no longer send representation to the Miracle ASC. They are, however, a thriving Narcotics Anonymous group, carrying the message to the still-suffering addict. We will continue to list their meetings on our meeting schedule, and they ask the Mid-America Region to do so as well. The In Between Group in Tonganoxie is struggling, but the message continues to be carried there as well. Larrytown reports attendance down but improving, Other groups report steady attendance. New Way and Step x Step have been growing, and both have had meetings where the meeting hall was full in excess of seating capacity. Apparently, this program works!!

H&I

Meetings are happening in the Men's medium pod of the Douglas County Jail every week, women's meetings twice a month. Two female addicts are carrying meetings to First Step every other Tuesday. The meetings are going well with an average of 12 to 20 women in attendance. As always, we are in desperate need of volunteers mostly women but we still need men as well.

The Miracle Area H&I Chair has met with Professional Treatment Services (PTS). For their "Bridging the Gap" program. This program invites a recovering addict to speak at their outpatient treatment program and talk about their life in 12-step recovery.

P.I.

Miracle Area Public Information has received 4 new literature racks and two have been placed in local health care facilities. Two more local facilities did not want racks but did request I.Ps and literature. The P.I. Subcommittee requested the purchase of 700 IP's.

Informational Pamphlets and pull-tab flyers are also being distributed in high-traffic areas on the Kansas University Campus. P.I. Subcommittee members also met with the Draw the Line Coalition and arranged to have literature distributed to high school counsellors in the area. Upcoming plans include distribution of same to junior high school counsellors as well.

Arrangements made by another P.I. Subcommittee member have made it feasible to print our meeting lists and pull-tab flyers in smaller quantities at the same cost. This allows us to keep the information much more current.

Activities

The Miracle Area Campout was a success, with about 50 in attendance for the events, though only about 6 or 8 people actually camped. There were also several group events which were well attended. Over two weekends, the Lotta Soul Group, Not So Famous Group, New Way Group and Step by Step groups held anniversary picnics, making for a lot of fun, fellowship and recovery to be shared.

Miracle Area welcomes incoming Activities Chair Megan, and our heartfelt thanks to outgoing Chair Christine T. for her service!! Megan brings a ton of enthusiasm to this important work, as well as several new ideas. We look forward to a lot of fun in recovery.

Public Relations Committee Report

Hello family,

We had another productive PR meeting yesterday.

H&I

There was no one available to facilitate the H&I meeting and due to a lack of members with an interest in attending the workgroup, it did not meet. Dusty assisted last RSC and sent a report that he sent out letters to all of the correctional facilities in the region. He also asked for help at the Ellsworth Correctional Facility H&I commitment due to being down to 3 volunteers.

Phoneline

The phoneline received 21 calls since the last quarter, most trying to find a meeting. This workgroup discussed taking the phoneline live. In order to accomplish this there will need to be a willing supply of volunteers to be trained to take calls. The workgroup believes this can be accomplished with at least 10 volunteers from each area to take a 3 hour shift each month. There was a question of whether our insurance would cover the volunteers taking calls. (Debby reports that we are covered).

Web

This workgroup worked on developing a new webpage with a different format. The goal is to make it user friendly for the newcomer accessing the site while still keeping the information available for seasoned

members (minutes, functions, etc). The workgroup is also reaching out to another region to develop a better way to update our meeting list more efficiently.

Communications

This workgroup has sent a proposal asking each group how many meeting lists need to be printed. How many does your group, sub-committees actually use in a 3 month period? PSA will be sent out to 2 radio stations in the preferred formats. A TV PSA is being put together for those public channels for areas or groups to use.

Presentation to Professionals

This workgroup has a date for the first presentation, April 10th from 8:30 to 11:30 at the Airport Hilton in Wichita. This will be the Friday morning before the convention. The workgroup would like to have a list of professional in your area, you would like to be invited. The workgroup will also have an interim meeting by online meeting and conference all on December 18, 2014 at 7pm.

The consensus cards don't have to be the way that we always achieve decisions in this process. We have through our research seen that this is a great way to facilitate discussion and gather consensus. It is understandable that change is fearful but with a little faith we can move forward together with spiritual principles that allow for a more inclusive process. Going forward we must remember that nothing we are doing is permanent and can always change and evolve. The only thing that doesn't change is our program. Remember our Traditions are non-negotiable, not our decision making process. The ideas and principles in our traditions and concepts are the forms to which we must fit our guidelines. The processes just have to line up with those guidelines.

Social Media:

In the newly formed Social Media workgroup, we discussed the set up of the Facebook group. We went ahead and created a group, named Mid America Region Narcotics Anonymous. The group is classified as a secret group, which means that only group members can see group posts or other activity (including member walls, pages, or newsfeeds). More detailed guidelines are available upon request. Members must be invited to join the group, by co-administrators or any group member, but each member has to be approved by a co-administrator. Any group member can post to the group, and co-administrators would monitor the appropriateness of posts, based on group guidelines adapted by Amber from Phoenix Group's Facebook group guidelines. These guidelines are pinned to the top of the group page. Regional Delegate Report:

Hello Family,

It's an awesome time to be alive and be a part of service in Narcotics Anonymous.

Tradition Book Project update: The Tradition Book project is still accepting input and there are several ways for doing workshops through the project page on www.na.org. The review and input is out for the Introduction and Tradition 1. Input for this is due January 31st. The deadline for Traditions 2-6 input is November 30th. Right now the Project Workgroup is requesting input on Traditions 6-12. They have received plenty of input on Traditions 1-5. So if you are doing workshops please focus on Traditions 6-12.

The suggested changes for the Guide to World Services are out for a 90 day review process. The changes were part of proposal BC and the 90 day deadline should be in December. Also they sent out the WSC 2014 Draft Record in September. In addition to these items NAWS has also sent out an essay in regards to the illicit production and distribution of the Basic Text. You can find this document at www.na.org/FIPT. This document gives a brief history of the Basic Text and what has happened and is happening with the production and distribution of "Baby Blues" and "Grey Form" books. There is some specific information about how to handle these things as a fellowship in the Fellowship Intellectual Property Trust.

The IDTs (Issue Discussion Topics) have been names but not posted to the website yet. The IDTs for this cycle are the Traditions book project, Group Support, Planning, and Welcoming Our Members.

Multi Zonal Service Symposium has happened. It was an amazing event for me personally. I was the Registration Guy for the committee and so I was more tied to being of service to the event than collecting information. I will be returning funds that were allocated for my attendance to the event. There were 13 members from our Region. Great show of support. The workshops and portions I was able to be a part of were not only well presentative and informative but well received. The event itself was a venue to bring unity to parts of our fellowship in the US that may have needed some. There was an opportunity for all of the RDs from the regions in Texas to meet together and talk about coming together to create statewide services. Amazing stuff. The NA history workshop was outstanding. The Men's luncheon had a speaker share that was one of our early WSC chairs and also a special worker for our fellowship. At the same event I was allowed an opportunity to hug a dear friend shortly after she was notified that with the passing of some of our predecessors that she was now the women with the longest clean time in NA. Such gifts cannot be tied to words. The words shared by members about this event brought tears of hope and joy in regards to the unity offered by the MZSS. Members from all over the US were able to learn about service and this has also started to spread through our regions in the US.

The Plains States Zonal Forum met at the end of the MZSS. With the way the original proposal was written for MZSS. The MZSS was intended as a one-time event. With that we have been tasked by the PSZF has sent a proposal to poll the regions on whether we should do it again or on-going. The MZSS workgroup also recommended to continue. So we need to discuss this and report back to PSZF in January.

PSZF has created a workgroup to research starting up a project for Sponsorship behind the Walls. Amber C. of our Region was elected the secretary for the Zone and I took the facilitator position. PSZF is also looking for another member who can be trained to be a web servant along with the current web servant so that the spirit of rotation may continue with skilled individuals. The next Zonal meeting will be in Abilene, Tx. Jan.

23-25th, 2015. Amber and I are making this a part of a different trip so we will be attending the zonal meeting and flying into Dallas on Thursday the 22nd. Nate and I have discussed options and decided the cost of flights would be cheaper than him driving. The cost of the motel is \$104 per night plus tax. We will submit a request for funds for the travel and Nate will have a request to be reimbursed for his flight cost. Also over the last three months I had the opportunity to attend the Nebraska and Colorado Regional Conventions. There were some great learning observations gained from attendance to both events. In addition valuable outreach to these neighboring regions on behalf of our region. The experience at CRCNA in regards to their H&I commitment was off the chain. They have an H&I hook-up for their Sunday morning speaker. This convention had 13 facilities connected. 10 of those were the state correctional institutes. They had 798 registrations, gave away 225 H&I packets and 128 newcomer packets. They had a special table to sign up for H&I and did an H&I training with DOC doing their volunteer training as well at the event. In addition they gave away basic texts. They also had a set of service workshops in addition to their recovery workshops as part of their convention. They put on a wonderful history workshop that had a packed house. These efforts all astounded me and gave me hope for our future efforts and a desire for our region to take on some new and creative projects that would attainable goals for us.

As always I am grateful to be of service in any capacity and would be glad to come share on a topic and do a workshop at an event in your area or at your area meeting.

I personally got a lot of information at the Phoneline workshop and was able to develop a plan to incorporate “live addicts” into our Mid-America Phoneline from the ESH of other Regions that have the same service we do. The NA history workshop was incredible and I recommend that everyone take the time to review all the information and pass it on as a resource to your Area's and Groups.
